


# SR 20: Corridor Facts

- The SR 20 corridor extends from Cartersville in Bartow County to Cumming in Forsyth County.
- These projects propose to alleviate congestion, improve east/west mobility, and reduce crash frequency along the SR 20 corridor.
- Completed projects will provide either **4 or 6 lanes** of roadway.
- The SR 20 corridor is approximately **39.23** miles in length.
- Design and engineering for the entire SR 20 corridor began in 2006.
- The current estimated cost to complete the active projects of the SR 20 corridor is \$782,514,921






# SR 92: Corridor Facts

- The SR 92 corridor extends from Douglas County to Cobb County.
- These projects propose to alleviate congestion, improve east/west mobility, and reduce crash frequency along the SR 92 corridor.
- Completed projects will provide **4-lanes** of roadway.
- The SR 92 corridor is approximately **7.79 miles** in length.
- Design and engineering for the entire SR 92 corridor began in 2006
- The current estimated cost to complete the active projects of the SR 92 corridor is **\$157,711,576**








# SR 5: Corridor Facts

- The SR 5 corridor extends from Blue Ridge towards McCaysville in Fannin County to the Tennessee State Line.
- These projects propose to alleviate congestion, improve north/south mobility, and reduce crash frequency along the SR 5 corridor.
- Completed projects will provide **4-lanes** of roadway.
- The SR 5 corridor is approximately **10.35** miles in length.
- Design and engineering for the entire SR 20 corridor began in 1993.
- The current estimated cost to complete the active projects of the SR 5 corridor is **\$160,995,299**




### SR 5 FROM N OF SR 2 TO PINEVIEW LANE - PHASE III Widening Project in Fannin County












# **ROME-CARTERSVILLE DEVELOPMENT CORRIDOR:** Corridor Facts








### SR 9 FROM WINDWARD PKWY TO FORSYTH COUNTY LINE Widening Project in Fulton County Congressional District 6










# Sunbelt Parkway/ SR 133: Corridor Facts

- The Governor's Road Improvement Program, commonly referred to as GRIP, is a system of proposed economic developmental highways in Georgia. GRIP was originally adopted in 1989 by the Georgia General Assembly.
- The SR 133 corridor extends from Albany in Dougherty County to Valdosta in Lowndes County.
- SR 133 is a Freight Corridor
- Completed projects will provide **4-lanes** of roadway.
- The SR 133 corridor active projects are approximately **29** miles in length.
- Design and engineering for the entire SR 133 corridor began in 2004.
- The current estimated cost to complete the active projects of the SR 133 corridor is \$244,826,016




## Sunbelt Parkway/ SR 133 CORRIDOR LOCATION








### SR 133 FM N OF COLQUITT COUNTY LINE TO N OF SR 112 Widening Project in Worth County Congressional District 8








## **US 441: Corridor Facts**

- The US 441 corridor travels the length of the state beginning at the Florida State Line and extending to the North Carolina State Line.
- US 441 is a Freight Corridor
- The US 441 corridor is a major north/south transportation artery in the east/central part of Georgia.
- Completed projects will provide **4-lanes** of roadway, usually divided with a grass median.
- The US 441 corridor is approximately 371 miles in length and is the longest of the GRIP corridors.
- The US 441 corridor active projects are approximately **54.7** miles in length.
- The current estimated cost to complete the active projects of the US 441 corridor active projects is \$459,845,775




## SR 4/US 1: Corridor Facts

- The Governor's Road Improvement Program, commonly referred to as GRIP, is a system of proposed economic developmental highways in Georgia. GRIP was originally adopted in 1989 by the Georgia General Assembly.
- US 1/SR 17 traverses the state from US 441 in Habersham County and extends south to the Florida State Line at Folkston. This corridor is active projects on this corridor are approximately **44.45 miles** in length.
- SR 4/US 1 is a Freight Corridor
- Completed projects will provide **4-lanes** of roadway.
- The current estimated cost to complete the active projects of the SR 4/US 1 corridor is **\$371,298,701**




### SR 4/SR 17/US 1 Location








#### SR 4 FM S OF CR 386/GREEN OAK RD TO CR 334/RESMONDO RD Widening Project in Toombs County Congressional District 12

- When we share our gifts, we make a better team and that team is able to be creative, innovative and diligent in the delivery of excellent service to our clients, internally and externally.








We are adding a professional services goal setting element to our federally funded engagements;
